From I-75 North

- 75 N to E. Galbraith Rd. exit (exit 10)
- Veer to the right off the ramp
- At stop light turn left on to Waldmann Dr.
- At stop sign turn right on Elliott Ave.
- Travel 2 stop signs and Municipal Building is on right

From I-75 South

- 75 S to the E. Galbraith Rd. exit (exit 10)
- Left off exit on to E Galbraith Rd.
- 2 Stop Lights turn left on Waldmann Dr.
- At stop sign turn right on Elliott Ave.
- Travel 2 stop signs and Municipal Building is on right

From Reading Rd.

- From Reading Rd. at E. Galbraith Rd. go North
- Turn left on to Clark Rd.
- Take Clark Rd. to Elliott Ave.
- Turn left on to Elliott Ave.
- Take Elliott Ave. to stop sign
- Municipal Building on left

OHIO'S FINANCIAL RESPONSIBILITY

LAW

IF YOU HAVE FAILED TO SUBMIT PROOF OF FINANCIAL RESPONSIBILITY TO A LAW ENFORCEMENT OFFICER, YOU NEED TO SUBMIT PROOF OF FINANCIAL RESPONSIBILITY TO THE TRAFFIC VIOLATIONS BUREAU WITH ANY FINE OR SUBMIT PROOF OF FINANCIAL RESPONSIBILITY TO THE COURT AT ANY COURT APPEARANCE.

THIS PROOF MUST HAVE BEEN EFFECTIVE AT THE TIME OF THE VIOLATION

OHIO LAW REQUIRES THAT PROOF OF FINANCIAL RESPONSIBILITY MUST BE SHOWN TO THE LAW ENFORCEMENT OFFICER OR COURT OFFICIAL. THIS INFORMATION WILL BE FORWARDED TO THE OHIO BUREAU OF MOTOR VEHICLES. FAILURE TO SHOW PROOF OF FINANCIAL RESPONSIBILITY WILL RESULT IN YOUR LICENSE BEING SUSPENDED FOR NINETY DAYS ON THE FIRST OFFENSE AND ONE YEAR ON ADDITIONAL OFFENSES. WORK PRIVILEGES CANNOT BE GIVEN.

YOU MUST BRING YOUR CITATION TO PAYOUT YOUR FINE

FOR ARLINGTON HEIGHTS, YOUR FINE (S) IS DUE ON OR BEFORE YOUR COURT DATE. IF YOU FAIL TO PAY YOUR FINE OR APPEAR IN COURT A WARRANT FOR YOUR ARREST WILL BE ISSUED AND YOUR DRIVING PRIVILEGES WILL BE CANCELED WITH THE STATE OF OHIO UNTIL CITATION IS CLEARED.
